Lord Mayor's Charitable Foundation is Australia's oldest and largest community foundation. We inspire philanthropy throughout Melbourne and the wider community, and influence positive social change through our support of charitable organisations delivering innovative, effective programs. Through our future focussed research, innovative grantmaking, partnerships and impact investing, we are helping communities across Melbourne transition to become healthy, resilient and sustainable.

Our history

Lord Mayor's Charitable Foundation was established in 1923 by Lord Mayor Sir John Swanson, a Melbourne business leader and visionary philanthropist.

Sir John saw the need to formally organise fundraising with the aim of providing a reliable source of income to support the city's public hospitals and charities.

Today, Lord Mayor's Charitable Foundation continues Sir John's vision of caring for the health and wellbeing of Melbourne and inspiring community philanthropy.

What is a community foundation?

Community foundations are uniquely placed to bring people, ideas and resources together to help build and strengthen communities. They are created by and for a community of people.

Community foundations provide everyone with an opportunity to participate in community philanthropy. They work in partnership with donors, local organisations, other funders and community organisations to pool and grow charitable funds, ensuring a sustainable source of funding to meet the immediate and long-term needs of the community.

Local communities know and understand their needs better than anyone else. Community foundations help to support positive change by bringing donors together, making grants and conducting research that improves well-being and tackles issues affecting a local community. Community foundations build partnerships around important initiatives and leverage other support.

Community foundations are a growing form of philanthropy all around the world. They offer opportunities for donors to work together with expert staff to make a real difference.

Our expertise in community philanthropy

Lord Mayor's Charitable Foundation works to address the key issues and needs of Melbourne, by providing grants, expertise and leadership to initiatives that most benefit the community.

We work with other funders and organisations to find solutions to the city's problems and through our future focussed research we are able to identify emerging issues and opportunities for positive social change in our society.

Through our grantmaking and community leadership, Lord Mayor's Charitable Foundation is having a profound and lasting effect on the lives of Melburnians.

Our Impact Areas

Lord Mayor's Charitable Foundation has made a lasting impact on the big challenges facing Melbourne. As these change over time, the Foundation monitors and researches current and emerging issues to prioritise and anticipate the needs of Melbourne. Our current grantmaking is focussed on four priority Impact Areas:



Education & Employment

Supporting young and older people to access education and work.



Environment & Sustainability

Transitioning towards a low-carbon economy, building a sustainable food system and protecting aquatic eco-systems.



Healthy & Resilient Communities

Addressing inequities in healthy ageing, building community resilience in the face of climate change, strengthening social cohesion and reducing discrimination.



Homelessness & Affordable Housing

Increasing the supply of affordable housing and preventing homelessness through early intervention initiatives.

1 In-depth community knowledge

With deep insight and understanding of local needs and opportunities, we are able to guide our donors in making the most strategic granting decisions. Through our Greater Melbourne Vital Signs research and Inspiring Philanthropy events, we promote discussion on the key issues affecting Melbourne.

2 Investing for perpetuity

Lord Mayor's Charitable Foundation is governed by the Lord Mayor's Charitable Foundation Act 2017 (Vic), enabling us to continue inspiring philanthropy and supporting the community into the future. The gifts we receive are held in trust creating a permanent legacy for our community.

3 Governance & accountability

Lord Mayor's Charitable Foundation is governed by a well-credentialed Board and has established several committees to assist in the strong governance of the Foundation. Our responsive grantmaking program is guided by the expertise received from external members of our Grants Advisory Panels.

Lord Mayor's Charitable Foundation is an independent philanthropic organisation, governed by an Act of Parliament and is proudly recognised as a registered charity with the Australian Charities and Not-for-profits Commission (ACNC).

The Lord Mayor's Charitable Fund is governed by the Federal Treasury's Public Ancillary Fund Guidelines 2011 (as amended 2016) and the Foundation's financial statements are audited annually by an independent auditor.

When donors join Lord Mayor's Charitable Foundation they become a valued member of a community of donors. We are committed to working collaboratively with our donors to bring their philanthropic vision to life and help them create an enduring impact with their charitable giving.

Ways you can make a difference in your community



Establish a Charitable Fund Account

Charitable Fund Accounts provide a simple, effective and rewarding way to support your community today, whilst creating a legacy in perpetuity for future generations. By structuring your giving, the issues you support will benefit from an ongoing source of income year-after-year.

A Charitable Fund Account within the Lord Mayor's Charitable Fund is a great way to support an issue you are passionate about, and also enables you to leverage our extensive grantmaking experience across our priority Impact Areas.

There are many reasons why people may choose to establish a Charitable Fund Account, including honouring the memory of a loved one, planning to give through your Will, or creating an enduring way to engage family members in giving.

You can establish a named Charitable Fund Account with as little as \$2,000 and grow this over time. Once the balance reaches \$10,000, distributions to eligible charities can be made. Donations made to Charitable Fund Accounts are tax-deductible and family and friends can also contribute to your Charitable Fund Account.



Establish a Community Fund Account

A Community Fund Account is a form of Charitable Fund Account that helps local councils build long-term philanthropic support within their local community. At Lord Mayor's Charitable Foundation, we believe that strong communities make a great contribution to the health and vitality of the people living within a municipality.



Join a Hive collective giving group

Join a community of like-minded donors helping to make Melbourne a better place. Lord Mayor's Charitable Foundation has established collective giving groups for each of our priority Impact Areas: Education Hive, Environment Hive, Health Hive and Housing Hive. Leave a gift in your Will


